The Board approved the Consent Docket as follows:



In other action, the Board:

- Reviewed and received the 2015-16 Audit Report and supporting material as presented by Maner Costerisan.
- Authorized the Superintendent to finalize and execute an agreement with the Ingham County Pheasants Forever Chapter, a local chapter of a Minnesota non-profit corporation, to provide for collaborative efforts for a wildlife habitat on the Ingham ISD campus.
- Authorized the purchase of food supplies during 2016-17 for the CACC Culinary Arts program and the Career Start store from Sysco in an amount not to exceed \$37,500, and to modify the amount not to exceed from US Foods to \$45,000, which is a decrease from the amount approved in July 2016 of not to exceed \$65,000.
- Approved the Public Relations and Communications Service Agreement with Mason Public Schools, for the term of October 2016 to June 30, 2018, with a not-to-exceed amount of \$30,000 annually.
- Approved the purchase of TEC furniture, including conference and meeting room tables, chairs, and workstation furniture, manufactured by Global Furniture Group, from Kentwood Furniture LLC, in an amount not to exceed \$81,039.
- Approved the increase in 1.0 FTE for school psychology and .10 FTE for occupational therapy. The increases in FTE will be funded by the districts utilizing this service through the Special Education tuition billback system.
- Approved the increase in 1.0 FTE Teacher and 3.0 FTE Paraprofessionals for the Autism Spectrum Disorder (ASD) classroom that will be funded by the districts utilizing this service through the Special Education tuition billback system.
