July 17, 2018

Organizational Meeting

The Ingham Intermediate School District Board of Education held the annual Organizational Meeting and elected Erin Schor as president for a period not to exceed two months, John Wolenberg as vice president, Michael Flowers as treasurer, and Nancy Stanley as secretary. Also, the Board adopted the bylaws, scheduled July 16, 2018 for next year's Organizational Meeting and June 18, 2018 as the date for the 2018-19 Public Budget Hearing. The Board supported the designation of depositories, continued the employee blanket bond and retained legal counsel.



In other action, the Board:

- Approved the .6 FTE increase in Speech and Language Pathologist services as presented.
- Approved increases in FTE for four special education positions: Teacher Consultant, Deaf and Hard of Hearing Services (.34), Occupational Therapist (.4) and Physical Therapist (.12).
- Approved the separation and creation of two positions at the Wilson Talent Center; 1.0 FTE Executive Director, CTE and 1.0 FTE Principal as presented.
- Approved the new OPEIU position for a .5 FTE Heartwood School Clinic Administrative Assistant as presented.
- Approved the hiring of Greg Molenda for the position of Technical Assistance and LEA Special Education Director position.
- Approved the hiring of Joseph Wenzel as the Wilson Talent Center Principal.
- Approved the resignation of Jennifer Rogers effective August 3, 2018.
- Approved the bid award to LJ Trumble Builders for the construction of the Law Enforcement Scenario House to be built in 2018 in the amount of \$300,785.
- Approved the bid purchase of new conference room tables for the WTC from Kentwood Office Furniture through the Fairfax County Purchasing Cooperative in the amount of \$24,807.50.
- Authorized the purchase of food supplies during 2018-19 for the WTC Culinary Arts program from Sysco, in a total amount not to exceed \$30,000.
- Approved the purchase of Phonak brand hearing equipment and hearing aids from Phonak, Inc.
 (Warrenville, IL) for a total not to exceed \$60,000 for Ingham ISD service area special education programs and services.



- Approved the agreement with Stockbridge Community Schools for .50 FTE Special Education administrator services, for the period of July 1, 2018 to June 30, 2019, with reimbursement from the district for the net cost which is estimated at \$54,000.
- Approved the bid award to Tomco Asphalt Inc. of Mason, MI in the amount of \$210,480.70 for the 2018 Heartwood School pavement rehabilitation project.
- Additional Agenda Item: Approved the hiring of Robert "Jon" Harpst to fill the Director of LEA Technology Services position.


The Board of Education discussed a request for out of state travel for Jason Mellema to the National Association of Educational Service Agencies (AESA) Conference.
