November 17, 2020

Presentation

Jason Mellema shared information on the Extended Continuity Learning Plan, COVID-19 Dashboard and two-way interactions.

Public Comment

Heartwood staff members joined the meeting to discuss concerns with in-person learning. Heartwood parents expressed their concern with going remote, they feel their students deserve in-person learning as schools are not spreaders of COVID-19. Another Heartwood parent expressed her concern about Heartwood staff being overworked.

In other action, the Board:

- Approved the purchase orders with Ferris State University, Baker College, and Lansing Community College to provide direct college credits to students attending Wilson Talent Center programs from July 2020 - June 2021 at the per credit hour rates listed below:
 - Ferris State \$141.00 per credit hour for Concurrent Enrollment \$282.00 per credit hour for Dual Enrollment and CRTEC 13th year
 - Baker College \$125.00 per credit hour for Dual Enrollment \$6,894.35 per student for CRTEC 13th year LCC - \$111.00 per credit hour for Dual Enrollment and CRTEC 13th year
- Authorized the WTC health programs to purchase study materials, practice tests and certification tests for the 2020-21 school year from NHA in an amount not to exceed \$36,000.



- Authorized the Superintendent to finalize and execute the agreement with the Bureau of Services for Blind Persons (LEO/BSBP) for the period of October 1, 2020 to September 30, 2021 for an Ingham ISD total cost share not to exceed \$34,815.
- Approved the Service Agreement with REMCAM for the REMC SAVE project for the term of December 8, 2020 to June 30, 2023, for a fixed fee of \$55,416.67 for the prorated 2020-2021 fiscal year, and \$95,000 per year for the 2021-2022 and 2022-2023 fiscal years.
- Approved the Resolution of Tribute for Terry Egerer.
- Approved the Extended Continuity Learning Plan recognizing that remote learning may be extended.
