October 20, 2020

Special Presentation

Jason Mellema presented the Extended Continuity Learning Plan, two-way interactions and COVID-19 Dashboard information to the Board of Education that is available for viewing on the transparency page of the Ingham ISD website.

Public Comment

Heartwood parents joined the meeting expressing their concern with students only attending two days a week and feel that their children need to be in attendance five days per week.

- Authorized the Superintendent to accept the ECSN grant award in the amount of \$2,092,921 and execute the grant agreement with MDE for the grant period October 1, 2020 through September 30, 2021.



 Approved the purchase order with Soliant Health LLC dba the Blazer Works division of Soliant Health, LLC to provide temporary staffing services for psychologists and social workers from September 2020 through June 2021, as needed and until positions are permanently filled, in an amount not to exceed \$370,000.
